The Account Executive works to maintain relationships with current business sponsors, will develop and increase sponsorships with businesses, churches and non-profit organizations throughout the Chippewa Valley, Eau Claire and surrounding areas to provide financial support for the ministry.

Primary Responsibilities:

- Maintain current business sponsors through face-to-face contact, develop and maintain strong working relationships with all clients, i.e. lunch meetings or at their place of business in the designated territory.
- Recruiting new business sponsors through prospecting and aggressively seeking new clients by networking, cold-calling, canvassing, referrals, and other means.
- Prepare radio campaign proposals, agreements, and schedules for potential and current sponsors.
- Develop radio script concepts in coordination with the sponsor and the station's copywriter that fits within FCC and ministry non-commercial and commercial compliance guidelines.
- Prepare and maintain accurate client files containing past agreements, orders, and scripts in our current CRM software and provide all sales related reports and information as requested by supervisor(s) within specified scheduled deadlines.
- When necessary, record client's radio announcement at their place of business.
- Report weekly activities to Chief Business Development officer.
- Attend training seminars and quarterly sales meetings as determined by the Chief Business Development Officer.
- All other duties as assigned.
